Payment Methods

All payments must be made within the first five days of the month; these must be made by direct debit mandate for which the corresponding SEPA form will be provided at the time of the student's acceptance. Receipt of payment will be granted upon presentation of the corresponding voucher. In case you need to

withdraw from the course, you must notify in advance within the 10 (ten) first days of the previous month of the cessation of the activity to stop the bank direct debit actions.

Registration

To formalize the registration you must attach:

- Registration form properly complemented.
- Photocopy of your identity document.
- Photocopy of the identity document of the representative (only in case of being underage).
- 2 passport-size photograph.
- Proof of the registration payment.
- Photocopy of the Health Insurance or the Health Security Card
- Data of the bank account for the needed bank instruction to direct debit of payments. (SEPA form filled)
- Scholarship-discount commitment signed (in case it has been granted).
